

RELEASE AND WAIVER OF CLAIMS (MINOR – Under 18)

As the legal guardian of the underage participant (the "Minor"), and on behalf of the Minor, I hereby give permission for the Minor to participate in certain Atlanta Hawks, L.P. (the "Hawks") promotional activities, including, the use of the equipment and/or the facilities of the Hawks in connection therewith (the "Activities"). I HEREBY ACKNOWLEDGE AND AGREE THAT PARTICIPATION IN THE AFOREMENTIONED ACTIVITIES INVOLVES RISK OF BODILY INJURY, DEATH AND/OR DAMAGE TO OR LOSS OF PROPERTY AND I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, BOTH KNOWN AND UNKNOWN, ON BEHALF OF THE MINOR. In consideration of the Hawks allowing the Minor to participate in the Activities, I hereby release and hold harmless the Hawks, Atlanta Hawks Management, LLC; ATL Hawks, LLC; Arena Operations, LLC; Arena Sports Marketing, LLC; ATL Investco, LLC; Entertainment Enterprises, LLC; Atlanta Fulton County Recreation Authority; and the National Basketball Association and its Member Clubs, their subsidiary and affiliated companies, and all of their respective directors, officers, shareholders, employees, agents, sponsors, successors and assigns (collectively, the "Hawks Parties"), from any and all rights, claims, demands, losses, damages, expenses, costs and actions (including reasonable attorneys' fees) which I, the Minor, and our heirs, executors, representatives or assigns may have in connection with the Minor's participation in the Activities, including without limitation, any bodily injuries, death, personal injuries or property damage that I or the Minor may incur or which may arise or result from the Minor's participation in the Activities. acknowledge that the Minor's participation in the Activities shall be subject to the rules and regulations which the Hawks or Hawks Parties may require and that I shall be obliged to pay for any damage that I or the Minor may cause in connection with the Minor's participation in the Activities.

Further, on behalf of the Minor, I hereby grant the Hawks Parties and their sponsors the perpetual, worldwide right to make both visual and/or audio recordings and still images of me and/or the Minor and to use the name, voice, likeness, picture, words, identity, testimonials, biographical information or any material based on or derived therefrom of me and/or the minor in connection with any of the Hawks games, Hawks-related programming, promotional/marketing materials, and/or other media (collectively, the "Media") and for the purpose of advertising, marketing and/or promoting the Hawks Parties and their sponsors. On behalf of the Minor, I agree that the rights granted hereunder shall include the perpetual, worldwide right of the Hawks Parties and their sponsors to edit, telecast, cablecast, web cast, rerun, record, publish, reproduce, use, license, print, distribute or otherwise exploit the Media in any manner and in any medium or forum whether now known or hereafter devised, in whole or in part, without any further compensation to me and/or the Minor.
